(1) HOW VIOLATION OCCURRED (Give detailed facts. Include the circumstances surrounding the violation which demonstrate the violation to be willful):

Violation of Condition 69, In that this officer along with CPS Michele Corson did conduct an investigation based on information that the offender was having contact with a minor [redacted] while they were employed as co-workers at Danny Boy's Restaurant located at 3808 Sun City Center Blvd, Ruskin, FL 33573. On 12/3/07 at approximately 16:30 hours this officer along with CPS Michele Corson did go to the victim's address of [redacted] for the purpose of conducting an interview with the victim and her mother. Through investigation, it was discovered per a statement provided by [redacted] that on numerous occasions while working together since approximately October 2006, the subject did discuss non-work related issues such as family problems, friends, high school, personal life, boyfriend issues and sexual issues in both private one-on-one conversations between the subject and [redacted] and group settings with other employees while at work. The subject received no permission from the court to have any contact with minors.

Subject refused to make a statement to this Officer in regard to this violation.

(3) HISTORY OF SUPERVISION: [ ] ADJUDICATION WITHHELD [ ] ADJUDICATED
Original sentence: On 11/22/05 the subject pled guilty to two counts of Lewd/Lascivious Battery (Engage). The subject was placed on two years Community Control for count 1, followed by 1 year Community Control followed by 7 years Sex Offender Probation on count 2. Count 2 is consecutive to count 1. The following special conditions of supervision were ordered: Random urine screens, 200 community service hours at 5 per month to be completed within the first three years, forfeit all evidence seized during investigation of this case to the Temple Terrace Police Department, Subject is not to receive

any money or financial compensation resulting from committing the crime, celebrity, fame, infamy, or notoriety achieved as a result of committing the crime including any payment, story rights, paid public appearances on television, radio, or other media, court costs in the amount of \$796.00, 10pm-6am curfew, submit DNA to FDLE, no victim contact, directly or indirectly, not to view, own, possess any obscene material or sexually stimulating visual or auditory material unless authorized as part of sex offender treatment, enroll and actively participate in sex offender treatment your own expense, make restitution to the victim for all medical and related services, submit to a warrantless search by the community control officer, not to reside within 1,000 feet of a school, park, daycare, or any place children congregate, no unsupervised contact with any child under the age of 18 without another adult present, who is responsible for the child's welfare, who has been advised of the crime, and who has been approved by the sentencing court until successful completion of sex offender treatment, you will not work for pay or as a volunteer at any school, daycare, park, playground, or any place children congregate, you will pay for polygraphs at least annually, for risk management and treatment purposes. The results will not be used as evidence for a violation of supervision, you will maintain a driving log and shall not operate a motor vehicle alone without the permission of your Officer, you will not use a Post Office Box without the prior approval of your Officer, If sexual contact occurred with the victim, you shall submit to and pay for an HIV test and release the results to the victim/family, Electronic monitoring when deemed necessary by the Department of Corrections and ordered by the court, you shall not reside with any one less than 18 years of age, this is a sexually violent offense under 394.910-394.931 regarding civil commitment.

**Summary of offender's current and prior participation in treatment, educational, and vocational programs:** Subject is currently attending Sex offender treatment through Joni Stewart LCSW located at 310 East Oak Avenue, Tampa, Fl. (813) 277-0080. Subject began treatment 12/14/05 and has been in continual attendance. As of her last treatment update it was stated that she is making "steady progress". In a recent conversation with Mrs. Joni Stewart the Subject has recently been placed on "corrective action".

**STATUS OF OTHER SPECIAL CONDITIONS:** Subject has submitted two DNA specimens to FDLB and has taken a HIV test with the results to the victim and his family.

- (4) **RECOMMENDATION:** This officer recommends that a warrant be issued for the subject's arrest and that she appear before the Court regarding her violation. This officer recommends that the subject should be sentenced as per the Florida Criminal Punishment Code. If the Court elects to depart from a period of incarceration, this officer feels the offender's supervision should be modified and the following conditions of supervision should be added: Subject not to be eligible for community control roll-over, mandatory electronic monitoring for the entire period of supervision, and not to work in any location where minors are employed.
