YNOPSIS OF INVOLVEMENT:

Interviewed Laura Nicholson and took a witness statement from her.

ACTION TAKEN:

On 01-18-08 at 1444 hrs at 1934 N. Hercules Avenue (McDonald's) I spoke with Laura Nicholson who is the manager. I asked Nicholson to tell me what she observed during the encounter that the police officer had with the elderly female. Nicholson told me that the elderly woman was in the driver thru and made her order. Nicholson stated the woman was asked to pull up to park because it was going to take a few minutes for her order. Nicholson stated the woman did not pull all the way up and a police officer was behind her and asked her nicely to pull forward. Nicholson stated the woman refused. Nicholson stated the officer exited his vehicle to speak with the woman and she began to argue with him and refused to move her vehicle. Nicholson stated the officer gave the woman a ticket and went back to his car when the woman got out of her car. Nicholson stated the woman was pointing her finger at the officer and he asked her to step back and she refused. Nicholson stated the officer ended up arresting the woman. Nicholson told me the officer did not do anything wrong. I asked Nicholson if the officer could have backed up and went around and she told me that traffic was bumper to bumper so no one could move.

I placed the original copy of Nicholson's statement into property at the Countryside Sub Station and sent a copy of her statement to Records.

Within minutes, cars were backed-up around the building and there was a crowd of 5-10 people standing around her car. INVESTIGATIVE ACTION TAKEN:

While in the drive-through lane at McDonald's, I observed a silver Lincoln Towncar, FL tag J16HFM R/O Joan Merola, drive a short distance past the last service window and stop. After receiving my drink from the last window, I attempted to drive around the Lincoln but was unable as there was not enough room behind her car to safely navigate without hitting her car. I pulled forward as far as possible with touching her car and attempted to back out (similar to pulling out of a parallel parking space), but was unable to because of traffic behind me.

I could see the driver's door window was open. While inside my car, I asked the driver, later identified as Merola, to pull forward so I could drive around her. Merola didn't respond. I again asked Merola to move her car forward. Merola refused to move her car but motioned with her left hand to drive around her. I replied that I couldn't because there wasn't enough room. Merola turned around in her seat, looked me directly in the eye, made an unusual face towards me, and again motioned for me to drive around her. Thinking she didn't hear me, I exited my car and approached her car to ask her again to move her car forward.

As I approached Merola's car, I asked her to pull her car forward about a foot so I could get around her. Merola yelled that she couldn't because she was waiting for her food and the people at the drive-through window told her to "park here, not there!" I told her she would still get her food if she moved forward a little and the people behind her could leave. Merola snapped back, "Don't you talk to me like that?" and started saying that "You think you can do whatever you want because you wear that blue suit?" "I don't think so, I know the Chief." At that instance, the manager from McDonald's brought Merola's food out and handed it to her.

Once Merola had her food, I told her there was no longer a need for her to park there and she could go home. Merola continued to yell at me that she knows the Chief and I can't talk to her like that. She then started demanding the Chief respond to McDonald's. I explained I would not request Chief Klein respond, but she could drive home and call him from there if she truly was a close personal friend as she claimed and then her car would no longer be blocking traffic. Merola still refused to move her car and continued to yell at me.

I pleaded with Merola for about 20 minutes to move her car forward one foot while she was calling me a "brat," "smart ass," and "dumbstuf." Merola also told me, "I hope you're Christian, because you're going to hell!" "You are an evil man," "Your wife is going to divorce you. If she didn't started already, she will soon. She's going to divorce you." "Your kids probably hate you too." "You are evil." "You are going to hell!"

After the disturbance caused by Merola and the personal insults towards me and my family, I told her I had had enough. I was returning to my car because there was no longer any reason for her to be there as she already has her food, so she needed to leave. I returned to my cruiser. As soon as I got into my cruiser, she got out of her car, slammed the door, and stormed back to me demanding I call the Chief.

I again told her to go home and call him from there. Merola continued to aggressively walk towards my cruiser. I ordered her to return to her car and leave. Merola stopped, but continued to yell at me. By this time I could see the McDonald's manager was now in the parking lot behind us walking food to customers and directing traffic out of another exit. I explained to Merola she was causing a disturbance in the parking lot and potentially costing McDonald's business. I told her to leave. Merola refused so I informed her she had two options at this point: 1) Get in her car and leave, or 2) I would arrest her for Disorderly Conduct and tow her car out of the way. The choice was hers.

Merola stormed back towards my cruiser saying, "You can't arrest me. You won't arrest me." I repeated the options and suggested she go home. Merola continued towards me with clenched fists saying, "You can't arrest me." Fearing she may escalate the disturbance into an even larger one, I exited my car and walked towards Merola telling her to go home. Merola stood with her arms crossed and refused to leave. I explained to Merola she was under arrest for Disorderly Conduct. I handcuffed her wrists behind her back and secured her in my cruiser. I got into Merola's car and drove it two feet forward, returned to my car, drove around Merola's car and parked where we were no longer obstructing traffic.

Not wanting to take Merola to jail, I attempted to contact Sergeant Lee for advice, but he left for the day. I spoke with Corporal Conyers and explained what had occurred. We contemplated contacting Merola's family for them to come get her, but she refused to give me any of their information. (It should be noted that most of the conversation with Corporal Conyers had to be repeated multiple times because I could not hear him on the phone while she was yelling at me from the backseat of the cruiser.) With no other options and Merola's continued refusal to comply with my orders, it was determined to transport Merola to jail for a City ordinance violation of Disorderly Conduct.

Officer C. Long responded and completed a custodial search of Merola, then transported Merola to the Pinellas County Jail where she was turned over to jail staff without incident.

Because Merola's car was not legally parked, contained personal property, and I am not authorized to allow her to leave her car on private property, I requested B.J.'s towing for an impound so it could be safely towed and secured at their lot. I completed a Vehicle Impound form and submitted it to records.

Prior to leaving McDonald's, I spoke with the manager, Sarah Curtis, who stated she had witnessed the disturbance caused by Merola and couldn't figure out why she refused to move forward a little. Curtis said she had also asked Merola to move her car forward before I did, but Merola refused her request as well.

Because of Merola's claim of being a personal friend of Chief Klein, I called Sergeant Lee and left a message on his voicemail about the incident.
